## **FDIC AND SIPC INSURANCE**

Your insured sweep deposits are eligible for \$250,000 (or \$500,000 for joint accounts) of FDIC insurance coverage per bank subject to applicable limits. Deposit accounts are not eligible for coverage by SIPC. Money Market Fund shares are protected by SIPC. SIPC is a nonprofit membership corporation formed by the U.S. Congress in 1970 to provide certain financial protection to clients of member securities firms. SIPC protection would ensure delivery of the portfolio assets to each eligible account up to \$500,000 in value (not more than \$250,000 in cash) in the case of financial failure of a SIPC member firm.
